We would like to invite you to participate in this year's 37th annual Bird Mart at the Central Point Grange Hall, Central Point, Oregon. There will be a Raffle. We will advertise in Oregon, Northern California, Nevada and the West Coast.

Vendor booth setup for the Bird Mart will begin on Saturday September 16th from 3 p.m. until 6 p.m. and Sunday morning, September 17th from 8 a.m. until 10 a.m. Coffee and muffins will be provided to vendors Sunday morning.

Doors will be open to the public on Sunday from 10 a.m. to 4 p.m. Booth spaces are about 10'x 10' and include 2 chairs and 1 table. The booth space rental is \$60.00 for non-members and \$50.00 for Northwest Bird Club members. Extra tables are available for \$10.00 each. There is a limit of 2 vendors per booth. Vendors are responsible for cleanup of their booth area. Refunds are given only if the Bird Mart should be cancelled.

Booth assignment is based on the order in which applications with payments are received. Available space is limited.

We want only healthy birds at the Bird Mart. Remove any visibly sick birds from the building immediately. Please keep cages clean. We require vendors to have adequate perch space for all birds in a cage. Vendors must reduce the number of birds in a cage if some are being plucked over crowded or stressed. The only animals allowed in this sale are birds --- no dogs, cats, fish, etc.
